#### **2.0 BRIEF SCOPE OF WORK**

Supply, Installation and Commissioning for 100KW Solar PV Carport project at Ministry of Water & Energy, Addis Ababa in Ethiopia. There should be standard system warranty of 1 year from the vendor. The detailed scope of work is defined in the Bidding document.

<b><u>QR for Building Solarisation: roof-top/ground mounted solar PV installation</u></b>	
<b>1 Technical Criteria</b>	
<b>1.1</b>	<p>1.1 a) The Bidder should have supplied, installed /got installed and commissioned Solar Photo Voltaic (SPV) based grid connected power plant of total minimum cumulative capacity of 80 kWp. The reference plants of a minimum cumulative capacity of 50 kWp must have been in successful operation for at least one (1) year after commissioning prior to the techno-commercial bid opening date. (For bidding in the Grid Connected Solar Project)</p> <p style="text-align: center;">Or</p> <p>1.1 b) The Bidder should have supplied, installed /got installed, and commissioned Solar Photo Voltaic (SPV) based off-grid power plant of total minimum cumulative capacity of 80 kWp, at least. The reference plants of a minimum cumulative minimum capacity of 50 kWp must have been in successful operation for at least one (1) year after commissioning prior to the techno-commercial bid opening date. (For bidding in the off-grid Solar Projects)</p>
<b><u>Notes for clause 1</u></b>	
a)	The reference SPV based grid connected/off-grid power plant as per clause 1.1 a) or b) should consist of minimum 25kWp Solar Power plant at a single location supplied, installed /got installed and commissioned by Bidder for a client.
b)	SPV based Roof Top/Ground Mounted/Floating Solar Power Project shall be considered eligible for QR purpose.
c)	Bidder shall submit certificate of successful completion and operation, as per Technical Criteria 1.1 (a) or (b) from the Owner
d)	The Bidder should be a legal entity, duly incorporated/registered under the laws of its country of domicile in one of the member/signatory countries of ISA as on the date of techno-commercial bid submission.
<b>2 Financial Criteria</b>	
<b>2.1</b>	The average annual turnover of the Bidder, should not be less than USD 500000 (US Dollar Five Hundred Thousand only) during the preceding three (3) financial years as on date of techno-commercial bid opening. In case a Bidder does not satisfy the average annual turnover criteria, stipulated above on its own, its Holding Company would be required to meet the stipulated turnover requirements as above, provided that the Net Worth of such Holding Company as on the last day of the preceding financial year is at least equal to or more than the paid- up share capital of the Holding Company. In such an event, the Bidder would be required to furnish along with its Techno-Commercial Bid, a Letter of Undertaking from the Holding Company, supported by the Holding Company's Board Resolution, as per the format enclosed in the Bid documents, pledging unconditional and irrevocable financial support for the execution of the Contract by the Bidder in case of award.

<b>2.2</b>	In case the Bidder is not able to furnish its audited financial statements on standalone entity basis, the unaudited unconsolidated financial statements of the Bidder can be considered acceptable provided the Bidder further furnishes the following documents on substantiation of its qualification:
<b>2.3</b>	Copies of the unaudited unconsolidated financial statements of the Bidder along with copies of the audited consolidated financial statements of its Holding Company
<b>2.4</b>	Certificate from the CEO/ CFO of the Holding Company, as per the format enclosed in the bidding documents, stating that the unaudited unconsolidated financial statements form part of the consolidated financial statement of the Holding Company.
<b>2.5</b>	In case where audited results for the last financial year as on the date of Techno Commercial Bid Opening are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case the Bidder is not able to submit the Certificate from a practicing Chartered Accountant certifying its financial parameters, the audited result of three consecutive financial years preceding the last financial year shall be considered for evaluating financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the financial results of the company are under audit as on date of Techno Commercial Bid Opening and the Certificate from a practicing Chartered Accountant certifying the financial parameters is not available.
<b><u>Notes for Clause 2</u></b>	
a)	Net worth means the sum total of the paid-up share capital and free reserves. Free reserves mean all reserves credited out of the profits and share premium account but does not include reserves credited out of the revaluation of the assets, write back of depreciation provision and amalgamation. Further any debit balance of Profit and Loss account and miscellaneous expenses to the extent not adjusted or written off, if any, shall be reduced from reserves and surplus,
b)	Other income shall not be considered for arriving at annual turnover.
c)	"Holding Company" and "Subsidiary" shall have the meaning ascribed to them as per Companies Act of domicile country of the bidder
d)	For value of reference projects required for Turnover indicated in foreign currency, the exchange rate as on seven (7) days prior to Techno Commercial Bid Opening date shall be used.
