National Clinical Management Protocol for management of Covid-19

The "National Clinical Management Protocol based on Ayurveda and Yoga for the management of Covid-19", released by the Ministry of AYUSH on 6 October 2020, is a milestone in the rapidly evolving scenario of Covid-19 responses in the country. As the pandemic wreaks havoc across the globe and mankind scrambles to put together effective counters to it, attempts are being made in many countries to integrate traditional interventions along with standard of care. In India, experience from Covid-19 response activities, have shown that Ayurveda and Yoga can play a pivotal role to augment the standard preventive measures for Covid-19. Taking note of this, expert committees from the concerned National Institutes and Central Councils for Research Centres along with a few other noted research institutions have collaborated and developed a protocol for the management of Covid-19. The Protocol is based on the following three considerations:

- 1) Knowledge from Ayurveda and Yoga classics and experience from clinical practices.
- 2) Empirical evidences and Biological plausibility.
 3) Emerging trends of ongoing
- clinical studies related to Covid-19.

The protocol is expected to contribute to the mainstreaming of Ayush solutions of the management of Covid-19, and will be immensely beneficial to the public since these solutions are easily accessible and will help to alleviate the hardships brought in by the pandemic. Pradhan Mantri Suraksha Bima Yojana(PMSBY)

The Scheme is available to people in the age group 18 to 70 years with a bank account who give their consent to join / enable auto-debit on or before 31st May for the coverage period 1st June to 31st May on an annual renewal basis. Aadhar would be the primary KYC for the bank account. The risk coverage under the scheme is Rs. 2 lakh for accidental death and full disability and Rs. 1 lakh for partial disability. The premium of Rs. 12 per annum is to be deducted from the account holder's bank account through 'auto-debit' facility in one installment. The scheme is being offered by Public Sector General Insurance Companies or any other General Insurance Company who are willing to offer the product on similar terms with necessarv approvals and tie up with banks for this purpose.

Pradhan Mantri Jan-Dhan Yojana (PMJDY)

(PMJDY) is National Mission for Financial Inclusion to ensure access to financial services, namely, a basic & deposit savings accounts, credit, insurance, remittance, pension in an affordable manner. Under the scheme, a basic savings bank deposit (BSBD) account can be opened in any bank branch or Correspondent Business (Bank Mitra) outlet, by persons not having any other account. Benefits under **PMJDY:**

- One basic savings bank account is opened for unbanked person.
- There is no requirement to maintain any minimum balance in PMJDY accounts.
- Interest is earned on the deposit in PMJDY accounts.
- Rupay Debit card is provided to PMJDY account holder.
- Accident Insurance Cover of Rs.1 lakh (enhanced to Rs. 2 lakh to new PMJDY accounts opened after 28.8.2018) is available with RuPay card issued to the PMJDY account holders.
- Life Insurance Cover of Rs. 30,000 to eligible PMJDY account holders who opened their account for the first time between 15.8.2014 to 31.1.2015 is available.
- An overdraft (OD) facility up to Rs. 10,000 to eligible account holders is available.
- PMJDY accounts are eligible for Direct Benefit Transfer (DBT), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana (APY), Micro Units Development & Refinance Agency Bank (MUDRA) scheme.



GOVERNMENT OF INDIA INITIATIVE

SVAMITVA Scheme is a Sector Central scheme launched by Hon'ble Prime Minister of India on National Panchayat Day i.e 24 April 2020. The Ministry of Panchayati Raj (MoPR) is the Nodal Ministry for implementation of the scheme. In the States, the Revenue Department / Land Records Department will be the Nodal Department and shall carry out the scheme with support of State Panchayati Raj Department. Survey of India shall work as the technology partner for implementation. The scheme aims to provide an integrated property validation solution rural India. for The demarcation of rural population areas would be done using Drone Surveying technology. This would provide the 'record of rights' to village household owners possessing houses in inhabited rural areas in villages which, in turn, would enable them to use their property as a financial asset for taking loans and other benefits financial from Bank.The scheme seeks to achieve the following objectives: -

- i. To bring financial stability to the citizens in rural India by enabling them to use their property as a financial asset for taking loans and other financial benefits.
- ii. Creation of accurate land records for rural planning.
- iii. Determination of property tax, which would accrue to the GPs directly in States where it is devolved or else, add to the State exchequer.
- iv. Creation of survey infrastructure and GIS maps that can be leveraged by any department for their use.
- v. To support in preparation of better-quality Gram Panchayat Development Plan (GPDP) by making use of GIS maps.
- vi. To reduce property related disputes and legal cases.

ATAL TUNNEL

On 3 October 2020, PM Narendra Modi inaugurated Atal Tunnel, the highway tunnel built under the Rohtang Pass in the eastern Pir Panjal range of the Himalayas on the Leh-Manali Highway in Himachal Pradesh. At a length of 9.02 km, it is the longest tunnel above 10,000 feet in the world and is named after former Prime Minister of India, Atal Bihari Vajpayee. It is horseshoe-shaped, single tube double lane tunnel with a roadway of 8 metres. It has an overhead clearance of 5.525 metres. It is designed for traffic density of 3000 cars per day and 1,500 trucks per day with max speed of 80 km/hr. The historic decision to construct a strategic tunnel below the Rohtang Pass was taken on 3 June 2000, when Atal Bihari Vajpayee was the PM. The Union Cabinet decided in 2019, to name the Rohtang Tunnel as Atal Tunnel to honour the contribution made by Atal Bihari Vajpayee. The Border worked Organisation Roads relentlessly to overcome major geological, terrain and weather challenges that included the most difficult stretch of the 587-metre Seri Nalah Fault Zone.





Architecture

Kangla Fort, which is also known as the Palace of Kangla is located close to Imphal River. Kangla Fort was the administrative seat of various Manipur kings from Nongda Lairen Pakhangba to Maharaja Kulachandra. The remains of the fort speak of Manipur's rich history and heritage. Comprising of temples, citadel and coronation halls, Kangla Fort is a hot favorite tourist site in Manipur among history buffs, photographers, and architectural enthusiasts.

Manipuri comes from Manipur in northeastern India. It has its roots in state's folk traditions and rituals, and often depicts scenes from the life of the God Krishna. Manipuri is characterized by smooth and graceful movements, female roles are especially fluid in the arms and hands, while male roles tend to have more forceful movements. The dance may be accompanied by narrative chanting and choral singing.



Chamthong or Kangshoi – A healthy vegetable stew

North-Eastern state of Manipur, dubbed "the Jewelled Land" due to its natural beauty, is also well known for its delicious cuisine. The food of Manipur is considered to be very healthy, preparations are simple and yet, tasty. This vegetable stew is very popular in Manipur. It consists of seasonal vegetables that are boiled and flavoured with sliced onions, cloves, salt, garlic, maroi, a bit of ginger and is served with rice or fish and is supposed to be consumed piping hot.

- 14) grilled or roasted local fish
- 15) fresh Coriander leaves

PREPARATION

- Wash and cut veggies in small bite-size pieces.
- Make julienne of ginger-garlic 2) and turmeric.
- 3) In a broad pan heat one litre of water.
- When water starts boiling, add ginger-garlic, turmeric, chilli, 4) jackfruit seeds, kidney beans and salt. You can avoid using ghost chilli. Instead, add some green chillies.
- 5) Boil for few minutes in high heat.
- 6) When fresh flavour starts emitting, add the veggies and white part of spring onion. Continue to boil.
- When veggies are half done, add the Amarnath greens or any other 7)
- kind of greens. Also add the green part of spring onion, dry and grilled fish, cover 8) and cook in medium-low heat until everything becomes soft.
- Before removing from heat adjust the seasoning and consistency. It should be soupy 9) consistency.
- Add some chopped coriander 10) leaves and remove from heat. Serve hot with a bowl of cooked rice.
